As of the close of business on September 8, 2011, (i) BVF beneficially owned 1,619,888 shares of Common Stock, (ii) BVF2 beneficially owned 996,200 shares of Common Stock, (iii) BVLLC beneficially owned 4,610,200 shares of Common Stock and (iv) ILL10 beneficially owned 529,400 shares of Common Stock.

Partners, as the general partner of BVF and BVF2, the manager of BVLLC and the investment adviser of ILL10, may be deemed to beneficially own the 7,755,688 shares of Common Stock beneficially owned in the aggregate by BVF, BVF2, BVLLC and ILL10.
