As of the close of business on December 31, 2017, (i) BVF beneficially owned 2,734,215 shares of Common Stock, (ii) BVF2 beneficially owned 1,769,797 shares of Common Stock, (iii) Trading Fund OS beneficially owned 459,326 shares of Common Stock and (iv) 758,550 shares of Common Stock were held in certain Partners managed accounts (the "Partners Managed Accounts").

Partners OS, as the general partner of Trading Fund OS may be deemed to beneficially own the 459,326 shares of Common Stock beneficially owned by Trading Fund OS.

Partners, as the general partner of BVF, BVF2, the investment manager of Trading Fund OS, and the sole member of Partners OS, may be deemed to beneficially own the 5,721,888 shares of Common Stock beneficially owned in the aggregate by BVF, BVF2, Trading Fund OS, and the Partners Managed Accounts, including 758,550 shares of Common Stock held in the Partners Managed Accounts.

Percent of class:

The following percentages are based on 59,685,598 shares of Common Stock outstanding, which is the total number of shares of Common Stock outstanding as reported in the Issuer's Prospectus filed with the Securities and Exchange Commission on November 6, 2017.
