The additional shares of restricted stock will vest as follows: 59 shares in even increments over 3 years beginning January 2, 2016, 57 shares in even increments over 4 years beginning January 2, 2016, 143 shares in even increments over 4 years beginning August 25, 2016 and 160 shares in even increments over 5 years beginning January 2, 2016.
