On April 29, 2016, the issuer declared a cash dividend of \$0.12 per share of common stock, payable June 24, 2016 to all shareholders of record on June 10, 2016 (the "Dividend"). In accordance with the terms of the Restricted Stock Agreements dated January 2, 2013, January 2, 2014, August 25, 2014, January 2, 2015 and January 4, 2016, 217, 96, 166, 320 and 395 additional shares of restricted stock were received by the reporting person in connection with the Dividend, respectively. The additional shares of restricted stock will vest as follows: 217 shares in even increments over 2 years beginning January 2, 2017, 96 shares in even increments over 3 years beginning January 2, 2017, 166 shares in even increments over 4 years beginning August 25, 2016, 320 shares in even increments over 4 years beginning January 2, 2017 and 395 shares in even increments over 5 years beginning January 4, 2017.
