(b) On August 1, 2008, Dr. Sanjay Jha informed Qualcomm Incorporated (the Company) that he was resigning as our Chief Operating Officer and Group President, Qualcomm CDMA Technologies, to accept employment with another company.

(c) On August 4, 2008, the Board of Directors of the Company appointed Len J. Lauer to the additional position of Chief Operating Officer of the Company. Mr. Lauer continues to serve as Executive Vice President and Group President. The required information about Mr. Lauer's previous business experience is contained in Part I, Item 1 of the Company's Annual Report on Form 10-K for the fiscal year ended September 30, 2007 under the heading Executive Officers and is incorporated herein by reference. In connection with his appointment, Mr. Lauer will receive a base salary of \$575,000 and a stock option grant, under the Company's 2006 Long-Term Incentive Plan, to purchase 250,000 shares of the Company's common stock at an exercise price of \$52.87 per share, which was equal to the fair market value of the Company's common stock on August 4, 2008 (the date of the grant). The vesting and service requirements for this stock option grant are identical in all material respects to the terms and conditions of stock options granted to other officers of the Company. In particular, the options vest and become exercisable over a five year period. Ten percent of the options vest six months after the date of grant, and thereafter 1/60th of the total options vest on a monthly basis.
