ATTACHMENT A

As of April 24, 2003, Select and Select Offshore are the beneficial owners of 740,900 shares of Common Stock of Atwood Oceanics, Inc. ("Common Stock"), for a total beneficial ownership of 5.35% of the outstanding shares of Common Stock. As the President and controlling shareholder of Select and the Manager of Select Offshore, Loening has the power to vote and to direct the voting of and the power to dispose and direct the disposition of the 740,900 shares of Common Stock owned by Select and Select Offshore.
