## **CELLCOM ISRAEL ANNOUNCES negotiations with golan telecom**

**Netanya, Israel – May 16, 2016** – Cellcom Israel Ltd. (NYSE: CEL) (TASE: CEL) (hereinafter: the "Company") announced today that following reports in the Israeli media as to negotiations between the Company and Golan Telecom Ltd., following the regulators' opposition to the proposed purchase of Golan Telecom by the Company, the parties are negotiating an agreement which would, if finalized and approved by the regulators, allow Golan Telecom to continue to use the Company's networks in the provision of its services. Entering such agreement is subject to further agreements which are yet to be reached and there is no certainty that such agreements will be reached nor as to the entering into such an agreement.
