Dual Directional Barrier Digital Plus Securities Based on the Worst Performing of the Dow Jones Industrial Average™ and the Russell 2000® Index Due June 2, 2023

The securities offered by this pricing supplement are unsecured senior debt securities issued by Citigroup Global Markets Holdings Inc. and guaranteed by Citigroup Inc. Unlike conventional debt securities, the securities do not pay interest and do not repay a fixed amount of principal at maturity. Instead, the securities offer a payment at maturity that may be greater than, equal to or less than the stated principal amount, depending on the performance of the **worst performing** of the Dow Jones Industrial Average™ and the Russell 2000® Index (the “worst performing index”) from its initial index level to its final index level.

The securities offer modified exposure to the performance of the worst performing index, with (i) a minimum positive return at maturity if the level of the worst performing index remains the same or appreciates from its initial index level to its final index level and (ii) 1-to-1 participation in any appreciation of the worst performing index in excess of the minimum positive return, from its initial index level to its final index level as described below. In addition, if the worst performing index depreciates within a limited range (not more than 30.00%), the securities provide for a positive return at maturity based on the absolute value of that depreciation. In exchange for these features, investors in the securities must be willing to accept a return based on whichever underlying index is the worst performing index and to forgo (i) any positive participation in the absolute value of any depreciation of the worst performing index if the worst performing index depreciates by more than 30.00% and (ii) any dividends that may be paid on the stocks that constitute either underlying index. In addition, investors in the securities must be willing to accept full downside exposure to the worst performing index if the worst performing index depreciates by more than 30.00%. **If the worst performing index depreciates by more than 30.00% from its initial index level to its final index level, you will lose 1% of the stated principal amount of your securities for every 1% by which the worst performing index has declined from its initial index level. There is no minimum payment at maturity.**

Your return on the securities will depend **solely** on the performance of the worst performing index. You will not benefit in any way from the performance of the better performing index. You may incur a significant loss if **either** underlying index performs poorly, even if the other performs favorably.

Investors in the securities must be willing to accept (i) an investment that may have limited or no liquidity and (ii) the risk of not receiving any amount due under the securities if we and Citigroup Inc. default on our obligations. **All payments on the securities are subject to the credit risk of Citigroup Global Markets Holdings Inc. and Citigroup Inc.**

## Additional Information

The terms of the securities are set forth in the accompanying product supplement, prospectus supplement and prospectus, as supplemented by this pricing supplement. The accompanying product supplement, prospectus supplement and prospectus contain important disclosures that are not repeated in this pricing supplement. For example, certain events may occur that could affect your payment at maturity, such as market disruption events and other events affecting the underlying indices. These events and their consequences are described in the accompanying product supplement in the sections “Description of the Securities—Certain Additional Terms for Securities Linked to an Underlying Index—Consequences of a Market Disruption Event; Postponement of a Valuation Date” and “—Discontinuance or Material Modification of an Underlying Index,” and not in this pricing supplement. The accompanying underlying supplement contains important disclosures regarding each underlying index that are not repeated in this pricing supplement. It is important that you read the accompanying product supplement, underlying supplement, prospectus supplement and prospectus together with this pricing supplement in connection with your investment in the securities. Certain terms used but not defined in this pricing supplement are defined in the accompanying product supplement.

**Postponement of the valuation date.** If the valuation date is not a scheduled trading day for either of the underlying indices or if a market disruption event occurs with respect to either of the underlying indices on the valuation date, the valuation date will be subject to postponement as described in the accompanying product supplement in the section “Description of the Securities—Certain Additional Terms for Securities Linked to an Underlying Index —Consequences of a Market Disruption Event; Postponement of a Valuation Date.” If the valuation date is postponed, the final index level of each of the underlying indices in respect of the valuation date will be determined based on (i) for any underlying index for which the originally scheduled valuation date is a scheduled trading day and as to which a market disruption event does not occur on the originally scheduled valuation date, the final index level of such underlying index on the originally scheduled valuation date and (ii) for any other underlying index, the final index level of such underlying index on the valuation date as postponed (or, if earlier, the first scheduled trading day for such underlying index following the originally scheduled valuation date on which a market disruption event did not occur with respect to such underlying index).

## Hypothetical Examples

The diagram below illustrates your payment at maturity for a range of hypothetical percentage changes from the initial index level to the final index level of the worst performing index. Your return on the securities will depend solely on the performance of the worst performing index. You will not benefit in any way from the performance of the better performing index.

**Investors in the securities will not receive any dividends that may be paid on the stocks that constitute either underlying index. The diagram and examples below do not show any effect of lost dividend yield over the term of the securities.** See “Summary Risk Factors—Investing in the securities is not equivalent to investing in either of the underlying indices” below.

Your actual payment at maturity per security will depend on the actual final index level of the worst performing index. The examples below illustrate how your payment at maturity will depend on whether the final index level of the worst performing index is greater than or less than its initial index level and by how much.

#### Example 1—Upside Scenario A.

Underlying index	Initial index level	Barrier level	Hypothetical final index level	Hypothetical index percent change
Dow Jones Industrial Average™	24,667.78	17,267.446	25,901.17	5%
Russell 2000® Index	1,647.989	1,153.592	2,471.984	50%

In this example, the Dow Jones Industrial Average™ has the lowest index percent change and is, therefore, the worst performing index. Because the worst performing index appreciated from its initial index level and is **greater than** its initial index level by **less than** the fixed return amount of 53.80%, your payment at maturity would be calculated as follows:

Payment at maturity per security = \$1,000 + the greater of (i) the fixed return amount and (ii) \$1,000 × the index percent change

= \$1,000 + the greater of (i) \$538.00 and (ii) \$1,000 × 5.00%

= \$1,000 + \$538.00

= \$1,538.00

Because the worst performing index appreciated from its initial index level to its hypothetical final index level and the fixed return amount is greater than the 5.00% return you would have received based on the performance of the underlying index, your total return on the securities at maturity in this scenario would equal the fixed return amount of 53.80%.

#### Example 2—Upside Scenario B.

<b>Underlying index</b>	<b>Initial index level</b>	<b>Barrier level</b>	<b>Hypothetical final index level</b>	<b>Hypothetical index percent change</b>
Dow Jones Industrial Average™	24,667.78	17,267.446	44,402.00	80%
Russell 2000® Index	1,647.989	1,153.592	2,636.782	60%

In this example, the Russell 2000® Index has the lowest index percent change and is, therefore, the worst performing index. Because the worst performing index appreciated from its initial index level to its hypothetical final index level by more than the fixed return amount of 53.80%, your payment at maturity would be calculated as follows:

Payment at maturity per security = \$1,000 + the greater of (i) the fixed return amount and (ii) \$1,000 × the index percent change

= \$1,000 + the greater of (i) \$538.00 and (ii) \$1,000 × 60%

= \$1,000 + (\$1,000 × 60.00%)

= \$1,000 + \$600.00

= \$1,600.00

### Example 3—Upside Scenario C.

<b>Underlying index</b>	<b>Initial index level</b>	<b>Barrier level</b>	<b>Hypothetical final index level</b>	<b>Hypothetical index percent change</b>
Dow Jones Industrial Average™	24,667.78	17,267.446	22,201.00	-10%
Russell 2000® Index	1,647.989	1,153.592	1,977.587	20%

In this example, the Dow Jones Industrial Average™ has the lowest index percent change and is, therefore, the worst performing index. Because the worst performing index depreciated from its initial index level to its hypothetical final index level, but not by more than 30%, your payment at maturity per security would reflect 1-to-1 positive exposure to the absolute value of the negative performance of the worst performing index and would be calculated as follows:

Payment at maturity per security = \$1,000 + (\$1,000 × the absolute index return of the worst performing index)



$$= \$1,000 + (\$1,000 \times 10.00\%)$$

$$= \$1,000 + \$100 = \$1,100.00$$

#### Example 4—Downside Scenario.

Underlying index	Initial index level	Barrier level	Hypothetical final index level	Hypothetical index percent change
Dow Jones Industrial Average™	24,667.78	17,267.446	29,601.34	20%
Russell 2000® Index	1,647.989	1,153.592	494.397	-70%

In this example, the Russell 2000® Index has the lowest index percent change and is, therefore, the worst performing index. Because the hypothetical final index level of the worst performing index is **less than** its barrier level, your payment at maturity in this example would reflect 1-to-1 downside exposure to the negative performance of the worst performing index from its initial index level to its hypothetical final index level and would be calculated as follows:

$$\begin{aligned}
 \text{Payment at maturity per security} &= \$1,000 + (\$1,000 \times \text{the index percent change of the worst performing index}) \\
 &= \$1,000 + (\$1,000 \times -70.00\%) \\
 &= \$1,000 - \$700.00 \\
 &= \$300.00
 \end{aligned}$$

You would incur a significant loss on your investment in the securities in this scenario based on the decline of the worst performing index, even though the other underlying index performed favorably.

#### Summary Risk Factors

An investment in the securities is significantly riskier than an investment in conventional debt securities. The securities are subject to all of the risks associated with an investment in our conventional debt securities (guaranteed by Citigroup Inc.), including the risk that we and Citigroup Inc. may default on our obligations under the securities, and are also subject to risks associated with each underlying index. Accordingly, the securities are suitable only for investors who are capable of understanding the complexities and risks of the securities. You should consult your own financial, tax and legal advisors as to the risks of an investment in the securities and the suitability of the securities in

light of your particular circumstances.

The following is a summary of certain key risk factors for investors in the securities. You should read this summary together with the more detailed description of risks relating to an investment in the securities contained in the section “Risk Factors Relating to the Securities” beginning on page EA-6 in the accompanying product supplement. You should also carefully read the risk factors included in the accompanying prospectus supplement and in the documents incorporated by reference in the accompanying prospectus, including Citigroup Inc.’s most recent Annual Report on Form 10-K and any subsequent Quarterly Reports on Form 10-Q, which describe risks relating to the business of Citigroup Inc. more generally.

**You may lose some or all of your investment.** Unlike conventional debt securities, the securities do not repay a fixed amount of principal at maturity. Instead, your payment at maturity will depend on the performance of the worst performing index. If the final index level of the worst performing index is less than its barrier level, the absolute return feature will no longer be available and you will lose more, and possibly significantly more, than 30.00% of the stated principal amount of the securities. In this scenario, you will lose 1% of the stated principal amount of the securities for every 1% by which the final index level of the worst performing index has declined from its initial index level. There is no minimum payment at maturity on the securities, and you may lose up to all of your investment.

**The securities do not pay interest.** Unlike conventional debt securities, the securities do not pay interest or any other amounts prior to maturity. You should not invest in the securities if you seek current income during the term of the securities.

**Your potential for positive return from depreciation of the worst performing index is limited.** The return potential of the securities in the event that the final index level of the worst performing index is less than its initial index level is limited to 30%. Any decline in the final index level of the worst performing index from its initial index level by more than 30% will result in a loss, rather than a positive return, on the securities.

**The securities are subject to the risks of both underlying indices and will be negatively affected if either of the underlying indices performs poorly, even if the other underlying index performs well.** You are subject to risks associated with both of the underlying indices. If either underlying index performs poorly, you will be negatively affected, even if the other underlying index performs well. The securities are not linked to a basket composed of the underlying indices, where the better performance of one could ameliorate the poor performance of the other. Instead, you are subject to the full risks of whichever of the underlying indices is the worst performing index.

**You will not benefit in any way from the performance of the better performing index.** The return on the securities depends solely on the performance of the worst performing index, and you will not benefit in any way from the performance of the better performing index. The securities may underperform a similar investment in both of the underlying indices or a similar alternative investment linked to a basket composed of the underlying indices, since in either such case the performance of the better performing index would be blended with the performance of the worst performing index, resulting in a better return than the return of the worst performing index.

**You will be subject to risks relating to the relationship between the underlying indices.** It is preferable from your perspective for the underlying indices to be correlated with each other, in the sense that they tend to increase or decrease at similar times and by similar magnitudes. By investing in the securities, you assume the risk that the underlying indices will not exhibit this relationship. The less correlated the underlying indices, the more likely it is that one or the other of the underlying indices will decline by more than 30% over the term of the securities. All that is necessary for the securities to perform poorly is for one of the underlying indices to decline by more than 30%; the performance of the underlying index that is not the worst performing index is not relevant to your return on the securities. It is impossible to predict what the relationship between the underlying indices will be over the term of the securities. **One underlying index represents 30 selected blue chip stocks in the United States and the other represents small capitalization stocks in the United States. Accordingly, the underlying indices represent markets that differ in significant ways and, therefore, may not be correlated with each other.**

**Investing in the securities is not equivalent to investing in either of the underlying indices.** You will not have voting rights, rights to receive any dividends or other distributions or any other rights with respect to either of the underlying indices. The payment scenarios described in this pricing supplement do not show any effect of lost dividend yield over the term of the securities. It is important to understand that, for purposes of measuring the performance of the underlying indices, the levels used will not reflect the receipt or reinvestment of dividends on either of the underlying indices. Dividend yield on the underlying indices would be expected to represent a significant portion of the overall return on a direct investment in the underlying indices, but will not be reflected in the performance of either of the underlying indices as measured for purposes of the securities (except to the extent that dividends reduce the levels of the underlying indices).

**Your payment at maturity depends on the closing level of the worst performing index on a single day.** Because your payment at maturity depends on the closing levels of the underlying indices solely on the valuation date, you are subject to the risk that the closing level of the worst performing index on that day may be lower, and possibly significantly lower, than on one or more other dates during the term of the securities. If you had invested directly in the stocks that constitute either of the underlying indices or in another instrument linked to the underlying indices that you could sell for full value at a time selected by you, or if the payment at maturity were based on an average of the closing levels of the worst performing underlying index over the term of the securities, you might have achieved better returns.

**The securities are subject to the credit risk of Citigroup Global Markets Holdings Inc. and Citigroup Inc.** If we default on our obligations under the securities and Citigroup Inc. defaults on its guarantee obligations, you may not receive anything owed to you under the securities.

**The securities will not be listed on any securities exchange and you may not be able to sell them prior to maturity.** The securities will not be listed on any securities exchange. Therefore, there may be little or no secondary market for the securities. CGMI currently intends to make a secondary market in relation to the securities and to provide an indicative bid price for the securities on a daily basis. Any indicative bid price for the securities provided by CGMI will be determined in CGMI's sole discretion, taking into account prevailing market conditions and other relevant factors, and will not be a representation by CGMI that the securities can be sold at that price, or at all. CGMI may suspend or terminate making a market and providing indicative bid prices without notice, at any time and for any reason. If CGMI suspends or terminates making a market, there may be no secondary market at all for the securities because it is likely that CGMI will be the only broker-dealer that is willing to buy your securities prior to maturity. Accordingly, an investor must be prepared to hold the securities until maturity.

**The estimated value of the securities on the pricing date, based on CGMI's proprietary pricing models and our internal funding rate, is less than the issue price.** The difference is attributable to certain costs associated with selling, structuring and hedging the securities that are included in the issue price. These costs include (i) the selling concession paid in connection with the offering of the securities, (ii) hedging and other costs incurred by us and our affiliates in connection with the offering of the securities and (iii) the expected profit (which may be more or less than actual profit) to CGMI or other of our affiliates in connection with hedging our obligations under the securities. These costs adversely affect the economic terms of the securities because, if they were lower, the economic terms of the securities would be more favorable to you. The economic terms of the securities are also likely to be adversely affected by the use of our internal funding rate, rather than our secondary market rate, to price the securities. See "The estimated value of the securities would be lower if it were calculated based on our secondary market rate" below.

**The estimated value of the securities was determined for us by our affiliate using proprietary pricing models.**

CGMI derived the estimated value disclosed on the cover page of this pricing supplement from its proprietary pricing models. In doing so, it may have made discretionary judgments about the inputs to its models, such as the volatility of and correlation between the underlying indices, dividend yields on the stocks that constitute the underlying indices and interest rates. CGMI's views on these inputs may differ from your or others' views, and as an underwriter in this offering, CGMI's interests may conflict with yours. Both the models and the inputs to the models may prove to be wrong and therefore not an accurate reflection of the value of the securities. Moreover, the estimated value of the securities set forth on the cover page of this pricing supplement may differ from the value that we or our affiliates may determine for the securities for other purposes, including for accounting purposes. You should not invest in the securities because of the estimated value of the securities. Instead, you should be willing to hold the securities to maturity irrespective of the initial estimated value.

**The estimated value of the securities would be lower if it were calculated based on our secondary market rate.**

The estimated value of the securities included in this pricing supplement is calculated based on our internal funding rate, which is the rate at which we are willing to borrow funds through the issuance of the securities. Our internal funding rate is generally lower than our secondary market rate, which is the rate that CGMI will use in determining the value of the securities for purposes of any purchases of the securities from you in the secondary market. If the estimated value included in this pricing supplement were based on our secondary market rate, rather than our internal funding rate, it would likely be lower. We determine our internal funding rate based on factors such as the costs associated with the securities, which are generally higher than the costs associated with conventional debt securities, and our liquidity needs and preferences. Our internal funding rate is not an interest rate that we will pay to investors in the securities, which do not bear interest.

Because there is not an active market for traded instruments referencing our outstanding debt obligations, CGMI determines our secondary market rate based on the market price of traded instruments referencing the debt obligations of Citigroup Inc., our parent company and the guarantor of all payments due on the securities, but subject to adjustments that CGMI makes in its sole discretion. As a result, our secondary market rate is not a market-determined measure of our creditworthiness, but rather reflects the market's perception of our parent company's creditworthiness as adjusted for discretionary factors such as CGMI's preferences with respect to purchasing the securities prior to maturity.

**The estimated value of the securities is not an indication of the price, if any, at which CGMI or any other person may be willing to buy the securities from you in the secondary market.** Any such secondary market price will fluctuate over the term of the securities based on the market and other factors described in the next risk factor. Moreover, unlike the estimated value included in this pricing supplement, any value of the securities determined for purposes of a secondary market transaction will be based on our secondary market rate, which will likely result in a lower value for the securities than if our internal funding rate were used.
