**Item 1. Security and Issuer.**

This Amendment No. 2 (the Second Amendment ) amends the initial Schedule 13D filed by the Reporting Person on May 23, 2005 and Amendment No. 1 to such Schedule 13D filed by the Reporting Person on February 21, 2007 (collectively, the Schedule 13D ) with respect to the Class B common shares, par value \$1.00 per share ( Class B Shares ), of American Greetings Corporation (the Company ). Capitalized terms used but not otherwise defined in this Second Amendment have the meanings ascribed to such terms in the initial Schedule 13D. The purpose of this Second Amendment is to report a change in the number of Class B Shares beneficially owned by the Reporting Person.

**Item 5. Interest in Securities of the Issuer.**

The information in Item 5 of the Schedule 13D is hereby amended and restated in its entirety as follows:

(a)-(b). The Reporting Person has the sole power to vote or dispose of 566,458 Class B Shares, including 133,655 Class B Shares that he has the right to acquire within 60 days pursuant to outstanding stock options that the Company granted to the Reporting Person as compensation. The 566,458 Class B Shares beneficially owned by the Reporting Person constitute approximately 16.3% of the Class B Shares outstanding as of October 5, 2009.

The number of Class B Shares beneficially owned by the Reporting Person does not include: (a) 200,000 Class B Shares owned by the Irving Stone Support Foundation, of which the Reporting Person is a trustee, (b) 78,800 Class B Shares beneficially owned by the Reporting Person's spouse, Judith Stone Weiss, in her individual capacity, or (c) 203,964 Class B Shares owned by the Irving I. Stone Foundation, of which the Reporting Person is a trustee. The Reporting Person disclaims beneficial ownership of such Class B Shares.

(c). On October 7, 2009, the Reporting Person sold 200,000 Class B Shares at a sale price of \$22.92 per share to the Company in a privately-negotiated transaction, pursuant to the Reporting Person's written Rule 10b5-1 plan and in accordance with the Amended and Restated Articles of Incorporation of the Company.

(d). No other person is known by the Reporting Person to have the right to receive or the power to direct the receipt of dividends from, or the proceeds from the sale of, the Class B Shares beneficially owned by the Reporting Person.

(e). Not applicable.
