RECENT EVENTS: DEREGISTRATION

This Post-Effective Amendment relates to the Registration Statement on Form S-8 (registration number 333-104812) (the <u>Registration Statement</u>) filed with the Securities and Exchange Commission on April 29, 2003, which registered 50,000 shares of common stock, par value \$.01 per share (the <u>Common Stock</u>), of AT&T Wireless Services, Inc. (the <u>Company</u>) and related participation interest.

The Company, Cingular Wireless Corporation (<u>Cingular</u>), Cingular Wireless LLC, Links I Corporation (<u>Links</u>), and, solely with respect to certain sections thereof, SBC Communications Inc. and BellSouth Corporation entered into an Agreement and Plan of Merger dated as of February 17, 2004 (the <u>Merger Agreement</u>), pursuant to which, among other things, Links, a wholly owned subsidiary of Cingular, would be merged with and into the Company, the Company would become a wholly owned subsidiary of Cingular and all outstanding shares of the Company s Common Stock (and associated Rights to Purchase Preferred Stock) would be converted into the right to receive \$15.00 in cash and each share of the Company s Series C Preferred Stock and Series E Preferred Stock would be converted in the right to receive an amount of cash equal to its then applicable liquidation preference (these actions are collectively referred to as the <u>Merger</u>).

On May 19, 2004, the Company held a special meeting of stockholders at which the stockholders approved and adopted the Merger Agreement and the transactions contemplated thereby and approved the Merger.

The Merger will become effective following the filing of a Certificate of Merger with the Secretary of State of the State of Delaware. In anticipation of the closing of the Merger, the Company has terminated all of its offerings of its Common Stock and related participation interests pursuant to its existing registration statements, including the Registration Statement. In accordance with an undertaking made by the Company in the Registration Statement to remove from registration, by means of a post-effective amendment, any securities of the Company which remain unsold at the termination of the offering, the Company hereby removes from registration all Common Stock registered under the Registration Statement which remain unsold as of the date hereof.
