CONTROLS AND PROCEDURES

PetroKazakhstan maintains disclosure controls and procedures and internal control over financial reporting designed to ensure that information required to be disclosed in the reports filed under the Exchange Act, as amended, is recorded, processed, summarized and reported within the time periods specified in the Commission's rules and forms. and Chief Financial Officer, after evaluating the effectiveness of PetroKazakhstan's disclosure controls and procedures (as defined in Exchange Act Rule 13a-15(e)) as of the end of the period covered by this Form 40-F, concluded that as of such date PetroKazakhstan's disclosure controls and procedures were effective for the purpose for which they were designed.

During the fiscal year ended December 31, 2004, there were no changes in PetroKazakhstan's internal control over financial reporting that have materially affected, or are reasonably likely to materially affect, PetroKazakhstan's internal control over financial reporting.

AUDIT COMMITTEE FINANCIAL EXPERT

The Board of Directors of the Company has determined that Jacques Lefevre is an "audit committee financial expert" (as defined in paragraph 8(b) of General Instruction B to Form 40-F). Mr Lefevre is "independent", as that term is defined in the listing standards of the New York Stock Exchange and Rule 10A-3 of the Securities Exchange Act of 1934.

CODE OF ETHICS

The Company has adopted a code of ethics (as that term is defined in Form 40-F) that applies to its directors and employees (including its principal executive officer, principal financial officer and controller). The Company will provide any person, upon request to the General Counsel and Corporate Secretary of the Company, with a copy of the code of ethics free of charge. To date, no amendment has been made to the code of ethics, nor there has been any waiver, including implicit waiver, granted from the code of ethics required to be disclosed in this annual report on Form 40-F.

PRINCIPAL ACCOUNTANT FEES AND SERVICES

For the years ended December 31, 2004 and 2003, professional services were performed by Deloitte & Touche LLP, the member firms of Deloitte Touche Tohmatsu, and their respective affiliates, including TOO Deloitte & Touche that has served as the principal accountant for the audit of the Company's annual financial statements (collectively, "Deloitte & Touche").

AUDIT FEES: The aggregate audit fees billed by Deloitte & Touche were \$394,011 in the year ended December 31, 2004 and \$646,951 in the year ended December 31, 2003. These fees include amounts for services relating to the listing of the Company on the London Stock Exchange and issuance of comfort letters.

AUDIT-RELATED FEES: The aggregate audit related fees billed by Deloitte & Touche were nil in the year ended December 31, 2004 and \$6,041 in the year ended December 31, 2003.

TAX FEES: The aggregate fees billed by Deloitte & Touche for professional services rendered for tax advice were \$10,175 in the fiscal year ended December 31, 2004 and \$40,671 in the fiscal year ended December 31, 2003.

ALL OTHER FEES: The Company did not incur any fees billed by Deloitte & Touche for services other than the services reported under the captions "Audit Fees", "Audit-Related Fees" and "Tax Fees" above for the years ended December 31, 2004 and 2003.

AUDIT COMMITTEE PRE-APPROVAL:

Under the terms of its mandate, the Audit Committee pre-approves every engagement by the Company of its accountants to render audit and non-audit services, and therefore no pre-approval policies and procedures have been established for purposes of paragraph (c) (7) (i) (B) of Rule 2-01 of Regulation S-X. In 2004, the Company's accountants did not render any audit-related and non-audit services to the Company. Consequently, the DE MINIMIS exception set out in paragraph (c) (7) (i) (C) of Rule 2-01 of Regulation S-X was not applicable to the Company during 2004.

OFF-BALANCE SHEET ARRANGEMENTS

The Company has no off-balance sheet arrangements required to be disclosed in this annual report on Form 40-F.

(3) Operating leases are mainly for rail cars that the Company uses to transport crude oil, refined oil products and certain equipments used in upstream operations. Although the Company is committed to lease rail cars, the terms of the contracts allow termination with a 30 day notice. The Company has no capital leases.

(4) The Company has an obligation of \$32.5 million for future site restoration costs as at December 31, 2004 which represents the estimated future cash outflows discounted at 8.5%. The total undiscounted estimated cash flows required to settle the obligations are \$77.4 million with the expenditures being incurred over ten years commencing in 2014.

(5) Work commitments are non-discretionary expenditures for seismic and drilling that the Company is contractually committed to under the terms of

its hydrocarbons licenses.

- (6) Purchase obligations represent contractual obligations for goods and services for which the services have yet to be provided or for which the Company has not yet taken title to the goods. All other purchase commitments are discretionary.

SALES COMMITMENTS

The Company has sales commitments under contracts with two customers to supply an agreed volume of crude oil within the first four months of 2005. The estimated value of these commitments is approximately \$43.1 million.

AUDIT COMMITTEE

The Company has a separately designated standing audit committee established in accordance with Section 3(a)(58)(A) of the Exchange Act. The Audit Committee is comprised of James B.C. Doak, Jacques Lefevre and Jan Bonde-Nielsen. Jacques Lefevre chairs the Audit Committee.
