- (1) New account as of October 2000 - Shares held in Trust pursuant to Directors Deferred Compensation Plan - a 16b-3 Plan. Report of transactions completed by Trustee on November 7, 2002.

- (2) Balance held in Trust pursuant to Directors Deferred Compensation Plan - a 16b-3 Plan. Report of transactions through September 2002. As of November 28, 2000, began 10-year distribution, per director's election. A total of 11,454 shares were distributed, each distribution of 3,818 shares, on November 28, 2000, May 17, 2001 and May 17, 2002, respectively, representing three-tenths of the total 38,180 shares to be distributed. These shares have been previously reported on Section 16 filings. The descending balance will continue to be held by the Trust through the 10-year distribution period.

- (3) Adjusted to reflect the 11,454 shares described in Footnote (2), now held directly.
