- The Reporting Person and Ross C. Hartley are co-trustees of the National Information Consortium Voting Trust ("Voting Trust") which holds 21,400,805 shares of NIC Inc. common stock, and as co-trustees they have voting and investment power with respect to the shares held by the Voting Trust. The Reporting Person disclaims beneficial ownership of the shares held of record by the Voting Trust, except to the extent of his pecuniary interest noted herein. The Reporting Person and his family members have in the aggregate a 25.3% pecuniary interest in the Voting Trust, represented by 1,020,866 shares held directly by the Voting Trust for the benefit of a trust, of which the Reporting Person is the beneficiary, and 4,391,140 shares held directly by the Voting Trust for the benefit of entities of which the Reporting Person acts as manager, except that the Reporting Person disclaims beneficial ownership over 1,848,396 of the shares held by one of these entities.

- (4) Mr. Fraser is the manager of this limited liability company owned by other members of his family. He disclaims beneficial ownership of these shares.
