(1) On January 5, 2006, the National Information Consortium Voting Trust ("Voting Trust"), for which the Reporting Person and Jeffery S. Fraser act as trustees, sold 2,000,000 shares of NIC Inc. ("NIC") common stock. As a result of the sale, the Voting Trust now owns 21,450,805 shares of NIC common stock, all of which are indirectly owned by the Reporting Person as one of the Trustees of the Voting Trust. Of this amount, the Reporting Person indirectly owns 4,964,337 shares held directly by the Voting Trust for the benefit of the Reporting Person as a direct beneficiary of the Voting Trust, and 500,472 shares held directly by the Voting Trust for the benefit of the Reporting Person's minor children.

(2) The Reporting Person also directly owns 623,469 shares of NIC common stock and the following stock options to purchase shares of NIC common stock: (i) 20,000 shares at \$6.97 per share, exercisable in four equal annual installments, beginning on November 10, 2004, and (ii) 25,000 shares at \$4.15 per share, exercisable in four annual installments, beginning on November 5, 2005.
