**ITEM 8.01 OTHER EVENTS**

On June 17, 2014, CyrusOne Inc. (CyrusOne) issued a press release announcing that it has commenced the public offering of 12,500,000 shares of its common stock. The underwriters will be granted an option to purchase up to 1,875,000 additional shares of common stock from CyrusOne at the public offering price, less underwriting discounts. CyrusOne expects to use the net proceeds of the offering to acquire 12,500,000 common units (or 14,375,000 common units if the underwriters exercise their option to purchase additional shares of CyrusOne's common stock in full, assuming one common unit will be purchased for every share of common stock issued by CyrusOne in the offering) of limited partnership interests in CyrusOne's operating partnership, CyrusOne LP, from a subsidiary of Cincinnati Bell Inc. A copy of the press release is furnished herewith as Exhibit 99.1.
