Marxe and Greenhouse share sole voting and investment power over 31,115 shares of Common Stock owned by Special Situations Cayman Fund, L.P., 1,401,962 shares of Common Stock owned by Special Situations Fund III, L.P., 2,220 shares of Common Stock owned by Special Situations Technology Fund, L.P. and 645,700 shares of Common Stock owned by Special Situations Technology Fund II, L.P. See Items 2 and 5 of this Schedule 13D for additional information.

Item 1. Security and Issuer.

This schedule related to the common stock of Precision Optics Corporation, Inc. (the ?Issuer?). The Issuer?s principal executive officers are located at 22 East Broadway, Gardner, MA 01440.

Item 2. Identity and Background.

The persons filing this report are Austin W. Marxe (?Marxe?) and David M. Greenhouse (?Greenhouse?), who are the controlling principals of AWM Investment Company, Inc. (?AWM?), the general partner of and investment adviser to Special Situations Cayman Fund, L.P. (?Cayman?). AWM also serves as the general partner of MGP Advisers Limited Partnership (?MGP?), the general partner of and investment adviser to Special Situations Fund III, L.P. (?SSF3?). Marxe and Greenhouse are also members of SST Advisers, L.L.C. (?SSTA?), the general partner of and investment adviser to Special Situations Technology Fund, L.P. (?Technology?) and the Special Situations Technology Fund II, L.P. (?Tech II?). (SSF3, Cayman, SSPE, Technology and Tech II will hereafter be referred to as, the ?Funds?).

The principal office and business address of the Reporting Persons, is 153 East 53rd Street, 55th Floor, New York NY 10022.

The principal business of each Fund is to invest in equity and equity-related securities and other securities of any kind or nature.

Mr. Marxe and Mr. Greenhouse have never been convicted in any criminal proceeding (excluding traffic violations or similar misdemeanors), nor have either of them been a party to any civil proceeding commenced before a judicial or administrative body of competent jurisdiction as a result of which he was or is now subject to a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws or finding any violation with respect to such laws. Mr. Marxe and Mr. Greenhouse are citizens of the United States.

Item 3. Source and Amount of Funds or Other Consideration.

Each Fund utilized its own available net assets to purchase the securities referred to in this Schedule.

Item 4. Purpose of Transaction.

The securities referred to in this Schedule have been acquired by each of the Funds for investment purposes and not with the purpose or effect of changing or influencing control of the Issuer. Each Fund acquired the securities in the ordinary course of business and is holding the securities for the benefit of its investors.

Item 5. Interest in Securities of the Issuer.

Cayman owns .4% of the shares outstanding, SSF3 owns 20.0% of the shares outstanding, Technology owns 0% of the shares outstanding and Tech II owns 9.2% of the outstanding shares. Messrs. Marxe and Greenhouse share the power to vote and direct the disposition of 2,080,997 of Common Stock owned by each of the Funds. Messrs. Marxe and Greenhouse are deemed to beneficially own a total of 2,080,997 shares of Common Stock or 29.7% of the outstanding shares.

On July 21, 2004 the Funds exercised their subscription rights to purchase common shares of Precision Optics Corporation, Inc. at a cost of \$1 per share. In the previous 13D Filing, the Special Situations Technology Fund II, L.P. erroneously showed an acquisition of 635,100 shares, the Fund actually acquired 634,100 shares.

Item 6. Contracts, Arrangements, Understandings or Relationships With Respect to Securities of the Issuer.

No contracts, arrangements, understandings or similar relationships exist with respect to the securities of the Company between Messrs. Marxe and Greenhouse and any other individual or entity.
