(1) Annual grant in connection with service on the Board of Directors. The shares represent restricted stock units that were received as an award, for no consideration. The restricted stock units shall vest as to 50% of the shares on November 18, 2015 and 50% of the shares on May 18, 2016. If the Reporting Person's service as a director terminates at any time due to death, the grant shall immediately become fully vested.

(2) Shares are held by H.C. Jones Living Trust, of which the Reporting Person is the trustee.

The shares are held in trust as follows: 21,800 by the Gregory C. Jones Trust, 21,800 by the Carolyn E. Jones Trust and 21,800 by Harvey C. Jones III Trust. The Reporting Person is co-trustee of each of the trusts. The Reporting Person disclaims beneficial ownership of such shares, except to the extent of his pecuniary interest therein.
