Item 8.01 Other Events.

On August 13, 2010, Circuit City Stores, Inc. (the "Company") filed the Monthly Operating Report for the period from June 1, 2010 to June 30, 2010 with the United States Bankruptcy Court for the Eastern District of Virginia. The Bankruptcy Court has had jurisdiction over the reorganization proceedings under Chapter 11 of the United States Bankruptcy Code for the Company and each of its wholly-owned United States and Puerto Rican subsidiaries since November 10, 2008. A copy of the Monthly Operating Report is attached as Exhibit 99.1 to this report and is incorporated by reference into this Item 8.01.

The Company cautions investors and potential investors not to place undue reliance upon the information contained in the Monthly Operating Report, which was not prepared for the purpose of providing the basis for an investment decision relating to any of the Company's securities.
