Item 5.02 Departure of Directors or Certain Officers; Election of Directors; Appointment of Certain Officers; Compensatory Arrangements of Certain Officers.

On February 1, 2016, the Compensation Committee of the Board of Directors and the Board of Directors of Alliance Data Systems Corporation (the "Company") approved long-term equity incentive compensation awards for the Company's executives and senior leaders, and such awards were granted on February 16, 2016. The long-term equity incentive compensation awards consist of 80% performance-based restricted stock units and 20% time-based restricted stock units and were made pursuant to the Company's 2015 Omnibus Incentive Plan. Consistent with past practice and subject to the discretion of the Compensation Committee of the Board of Directors of the Company, the performance restriction on the performance-based restricted stock unit awards will lapse provided that the Company's 2016 income before income taxes determined in accordance with GAAP ("EBT") meets or exceeds \$994 million to achieve 50% of the target award; \$1,104 million to achieve 100% of the target award; and \$1,214 million to achieve 150% of the target award, with a fixed scale between \$994 million and \$1,214 million. Upon achievement of the performance target, the performance restriction will lapse with respect to 33% of the award on February 16, 2017, with respect to an additional 33% of the award on February 16, 2018 and with respect to the final 34% of the award on February 19, 2019 (each such date a "Vesting Date") provided that the participant is employed by the Company on each such Vesting Date. The same percentages and Vesting Dates apply to the time-based restricted stock unit awards.

The total target number of time-based restricted stock units ("TBR SU") and performance-based restricted stock units ("PBR SU"), which may be adjusted up or down based on the Company's performance as described, granted to the Company's chief executive officer, chief financial officer and named executive officers are as follows:
