ITEM 1.01 ENTRY INTO A MATERIAL DEFINITIVE AGREEMENT.

On February 22, 2010, Apogee Technology, Inc.'s Board of Directors approved transactions for receipt of \$66,000 in proceeds from the sale of a promissory note. Mr. Herbert M. Stein loaned the company \$66,000 pursuant to the promissory note attached hereto. The promissory note bears simple interest of 8% per year and is to be repaid in cash after 180 days.

The promissory note is attached hereto as Exhibit 99.1, and is incorporated herein by reference.
