Explanation of Responses:

(1) On December 19, 2007, the Board of Directors of Prospect Acquisition Corp. (now Kennedy-Wilson Holdings, Inc.) (the "Issuer") authorized the company to repurchase an aggregate 937,500 shares of its common stock from the initial stockholders, for a price of \$0.0001 per share.

(2) William Landman is the Managing Member of Capital Management Systems, Inc., and may be deemed to beneficially own the 376,378 shares of common stock beneficially owned by Capital Management Systems, Inc. William Landman does not own any common stock warrants directly. Capital Management Systems, Inc. is the beneficial owner of a warrant to purchase 420,000 shares of common stock. William Landman disclaims beneficial ownership of the warrants to purchase shares of common stock except to the extent of his pecuniary interest therein and this report shall not be deemed an admission that William Landman is the beneficial owner of the securities for purposes of Section 16 or for any other purpose.

(3) Sponsors' warrants (the "Sponsors' Warrants") are identical to the warrants offered by the Issuer in its initial public offering (the "IPO"), except for those differences set forth in the final prospectus relating to the IPO (the "Prospectus"). In addition, the Sponsors' Warrants generally are not transferable, assignable or saleable until 30 days after the completion of the Issuer's initial business combination, except to certain permitted transferees, and shall expire worthless if the Issuer does not complete an initial business combination within 24 months after the date of the Prospectus.

(4) The Sponsors' Warrants become exercisable on the later of the completion of the Issuer's initial business combination and 15 months from the date of the Prospectus, provided that the Sponsors' Warrants can not be exercised while subject to the transfer restrictions described above.

- (5) The Sponsors' Warrants expire five years from the date of the Prospectus of the Issuer or earlier upon redemption or liquidation of the Issuer.
