**Item 1. Security and Issuer.**

This Amendment No. 12 to Schedule 13D (the Statement ) relates to the Common Stock, no par value per share (the Common Stock ), of Winmark Corporation, a Minnesota corporation (the Company ). Depending on the same factors, the Reporting Person may decide in the future to sell all or part of his investments in the Issuer s Common Stock.
