EXPLANATORY NOTE

This Amendment No. 9 to Schedule 13D (Amendment) relates to American Depository Shares (ADSs) of Coca-Cola FEMSA, S.A.B de C.V. (the Issuer), each of which represent 10 Series L Shares, without par value (Series L Shares). This Amendment is being jointly filed by Cascade Investment, L.L.C. (Cascade), Bill & Melinda Gates Foundation Trust (the Trust), William H. Gates III and Melinda French Gates (collectively, the Reporting Persons), to amend and supplement the Items set forth below of the Reporting Persons Schedule 13D previously filed with the Securities and Exchange Commission on August 1, 2008, as amended on January 15, 2010, January 29, 2010, February 10, 2010, March 10, 2010, May 7, 2010, May 21, 2010, March 8, 2011 and March 14, 2011. Neither the present filing nor anything contained herein shall be construed as an admission that the Reporting Persons constitute a group for any purpose.

Item 3. Source and Amount of Funds or Other Consideration

Each of Cascade and the Trust purchased its respective ADSs and Series L Shares with its working capital in the amount set forth in Exhibits 99.1 and 99.2 to this filing.

Item 5. Interest in Securities of the Issuer

(a) See items 11 and 13 of the cover pages to this Schedule 13D for the aggregate number and percentage of Series L Shares beneficially owned by each of the Reporting Persons.
