*Amendment of 2009 Equity Incentive Plan*

On May 23, 2014, Informatica Corporation ( Informatica ) held its Annual Meeting of Stockholders (the Annual Meeting ). At the Annual Meeting, the stockholders of Informatica voted on and approved an amendment to Informatica s 2009 Equity Incentive Plan (the 2009 Plan ) to increase the number of shares of Informatica s common stock reserved for issuance thereunder by 6,300,000 shares. The terms and conditions of the 2009 Plan are described in Informatica s Proxy Statement dated April 10, 2014.

A copy of the amended 2009 Plan will be filed as an exhibit to Informatica s Quarterly Report on Form 10-Q for the quarter ended June 30, 2014.
