**AMENDMENT NO. 14 TO
STATEMENT ON SCHEDULE 13D**

This Amendment No. 14 (this "Amendment") amends and supplements the Statement on Schedule 13D filed by Patrick M. Byrne, John B. Pettway, High Plains Investments LLC and Haverford Valley L.C. dated November 14, 2002, as amended to date (the "Original 13D"), relating to shares of the common stock, par value \$0.0001 per share (the "Shares") of Overstock.com, Inc., a Delaware corporation (the "Issuer"), whose principal executive offices are located at 799 W. Coliseum Way, Midvale, Utah 84047. Capitalized terms used but not defined herein have the meanings ascribed to them in the Original 13D.

Item 5 of the Original 13D is hereby amended and supplemented as follows:

As set forth herein, Dr. Byrne beneficially owns 5,810,819 Shares, which represent 18.1% of the outstanding Shares, based upon the number of Shares outstanding as of the most recent practicable date, and calculated in accordance with Rule 13d-3, and excluding 63,775 shares of the Issuer's Blockchain Voting Series A Preferred Stock (the "Series A Preferred"). The Series A Preferred votes together with the Shares and with the Issuer's Voting Series B Preferred Stock. Dr. Byrne shares voting and dispositive power over 4,640,824 Shares with High Plains Investments LLC and Haverford Valley L.C. and shares voting and dispositive power over 119,972 Shares with the Patrick Byrne Foundation Inc. Dr. Byrne has no pecuniary interest in such 119,972 Shares. Dr. Byrne disclaims beneficial ownership of the Shares held by High Plains Investments LLC, Haverford Valley L.C. and all other persons except to the extent of his pecuniary interest, if any, in the Shares held by any such person. Dr. Byrne has sole voting and dispositive power over 1,050,023 Shares. Dr. Byrne also has sole voting and dispositive power over 63,775 shares of Series A Preferred.

None of the Reporting Persons had any transactions in the Issuer's securities in the last 60 days. High Plains Investments LLC sold 147,499 Shares on September 6, 2018, 451,379 Shares on September 7, 2018 and 175,425 Shares on September 10, 2018. High Plains Investments LLC donated 37,000 Shares on September 18, 2018.

Item 6. Contracts, Arrangements, Understandings or Relationships with Respect to Securities of the Issuer

As previously reported, effective January 4, 2017, Dr. Byrne pledged 212,415 Shares of the Issuer to a commercial bank in connection with a loan. Effective May 25, 2017 Dr. Byrne subjected an additional 100,000 Shares of the Issuer to the pledge to the same bank in connection with the same loan. Effective December 13, 2018 Dr. Byrne subjected an additional 49,000 Shares of the Issuer to the pledge to the same bank in connection with the same loan. Effective December 17, 2018 Dr. Byrne subjected an additional 152,000 Shares of the Issuer to the pledge to the same bank in connection with the same loan.

As previously reported, effective August 17, 2015, High Plains Investments LLC pledged 1,168,185 Shares of the Issuer to a commercial bank in connection with the establishment of a line of credit to High Plains Investments LLC. At the same time, Dr. Byrne pledged 232,565 Shares to the bank in connection

with the same line of credit. Effective December 21, 2018 Dr. Byrne transferred these 232,565 Shares of the Issuer to the pledge to the same bank in connection with the loan described above. Accordingly, as of the date of this statement, Dr. Byrne has pledged a total of 745,980 Shares of the Issuer to the commercial bank in connection with the loan, and High Plains Investments LLC has pledged 1,168,185 Shares to the same bank in connection with the line of credit.

The Issuer and Patrick M. Byrne, individually and as representative, are parties to a Registration Rights Agreement dated December 15, 2016 and amended effective March 10, 2017, relating to the Series B Preferred.
