#### Investment description

- Linked to the Energy Select Sector SPDR® Fund

- Unlike ordinary debt securities, the securities do not pay interest at a specified rate or repay a fixed amount of principal at maturity. Instead, the securities provide for a Redemption Amount that may be greater than, equal to or less than the Principal Amount of the securities, depending on the performance of the Fund from its Starting Price to its Ending Price.

- The Redemption Amount will reflect the following terms:

#### If the price of the Fund increases:

You will receive the Principal Amount plus 150% participation in the upside performance of the Fund, subject to a maximum total return at maturity of 45% to 50% (to be determined on the Pricing Date) of the Principal Amount

**If the price of the Fund decreases, but the decrease is not by more than 15%, or does not change:**

You will be repaid the Principal Amount

**If the price of the Fund decreases by more than 15%:**

You will receive less than the Principal Amount and will have 1-to-1 downside exposure to the decrease in the price of the Fund in excess of 15%

## How the Redemption Amount is calculated

The Redemption Amount will be determined as follows:

- If the Ending Price is greater than the Starting Price, the Redemption Amount will be equal to the lesser of:

(i) \$1,000 *plus*

(ii) the Capped Value

- If the Ending Price is less than or equal to the Starting Price, but greater than or equal to the Threshold Price, the Redemption Amount will be equal to \$1,000

- If the Ending Price is less than the Threshold Price, the Redemption Amount will be equal to \$1,000 *minus*

**In such a case, you will lose up to 85% of your Principal Amount.**
