The demutualization was effective October 26, 2001. Principal Financial Group, Inc. closed in initial public offering at \$18.50 per share on that date. It distributed shares to former holders of membership interests on December 10, 2001.

The reported phantom stock units were acquired under Principal Life Insurance Company's excess benefit plan as a result of the demutualization of Principal Mutual Holding Company and will be settled upon the reporting person's retirement or other termination of service.
