(1) Restricted shares granted under the PG&E Corporation 2006 Long-Term Incentive Plan (LTIP).

Restricted Stock Units (RSUs) granted under the PG&E Corporation 2006 LTIP. RSUs are payable in shares of PG&E Corporation common stock on a one-for-one basis upon a director's death, disability, retirement, or a change in control, as defined in the PG&E Corporation 2006 LTIP.

(3) This total includes 881.35 units of phantom stock granted under the PG&E Corporation Non-Employee Director Stock Incentive Plan (SIP), and reflects the acquisition of 8.42 units of phantom stock on 4/15/08, 8.59 units of phantom stock on 7/15/08, 11.03 units of phantom stock on 10/15/08, and 9.27 units on 1/15/09 pursuant to a dividend reinvestment feature of the SIP. This total also includes 832.33 RSUs granted under the PG&E Corporation 2006 LTIP and reflects the acquisition of 5.26 RSUs on 4/15/08, 5.37 RSUs on 7/15/08, 6.89 RSUs on 10/15/08, and 5.79 RSUs on 1/15/09 pursuant to a dividend reinvestment feature of the 2006 LTIP. The phantom stock units and RSUs are automatically payable in shares of PG&E Corporation common stock only.
