- The Restricted Stock Units (RSUs) were granted pursuant to the Company's Amended and Restated 1991 Equity Incentive Plan (the "1991 Plan"). RSUs vest in four equal annual installments of 25% each commence April 28, 2010. Vested RSUs will be paid in shares of the Company's common stock on a one-to-one basis unless payment is otherwise deferred by the reporting person.
- (1) These shares include 25,000 RSUs which is fully exercisable on 7/31/2010 and 11,400 RSUs which are exercisable in four equal annual installments of 2,850 each commencing 4/29/2009. Vested RSUs are paid in shares of the Company's Common Stock on a one-to-one basis, unless deferred by the reporting person.
  - (2) These shares are exercisable in four equal annual installments of 25% each commencing 04/28/2010.
