(1) On February 17, 2010 the Issuer granted the Reporting Person a Restricted Stock Award (RSA) of 7,684 restricted shares of First Midwest Bancorp, Inc. Common Stock under the First Midwest Bancorp, Inc. Omnibus Stock Incentive Plan (Plan) which were scheduled to vest in two equal annual installments on the second and third anniversary of the date of grant. On February 17, 2012, 3,842 shares of the originally granted RSAs vested, of which 1,370 shares were surrendered by the Reporting Person in order to satisfy tax withholding obligations. This form is being filed to reflect the surrender of such shares to satisfy the Reporting Person's tax withholding obligation.

(2) Pursuant to a statement dated December 15, 2011, reflects 9 shares sold from the Reporting Person's account under the First Midwest Bancorp, Inc. Savings and Profit Sharing Plan in satisfaction of quarterly Plan administration fees.

(3) Between May 25, 2011 and February 21, 2012 the Reporting Person acquired the following shares of First Midwest Bancorp, Inc. Common Stock under the First Midwest Bancorp, Inc. Savings and Profit Sharing Plan: (a) 269 shares pursuant to quarterly match contributions from the Company; (b) 31 shares pursuant to the Dividend Reinvestment feature of the Plan; and (c) 524 shares pursuant to payroll contributions. This information is based on plan statements dated January 6, 2012, January 23, 2012 and February 16, 2012, respectively.
