The reporting person has the right to transfer the value of the phantom stock account into an alternative investment account within the plan.
- (2) The balance includes phantom stock units acquired via dividend reinvestment on April 2, July 2, and October 2, 2014, and January 5, 2015, at prices ranging from \$44.68 to \$50.92 per unit.
