- (4) reporting person provided that such date shall be at least two (2) years after the end of the plan year with respect to which such elective deferrals relate. The reporting person may transfer his investment in the notional shares - optional to an alternative investment account, subject to the terms of the Issuer's deferred compensation plan for non-employee directors.

- (5) Each restricted stock unit represents a contingent right to receive the economic equivalent of one share of PRU common stock.

- (6) The restricted stock units vest the earlier of the annual meeting or in one year on May 10, 2017.
