- (1) On January 4, 2010, the Issuer entered in an agreement with Willing L. Biddle (the "Reporting Person") whereby the Reporting Person was granted a restricted stock award of 5,000 shares of Class A Common Stock pursuant to the Issuer's Amended and Restated Restricted Stock Award Plan (the "Restricted Stock Award Plan").
- (2) This figure includes 42,500 restricted shares of Class A Common Stock issued pursuant to the Restricted Stock Award Plan. On January 4, 2010, restrictions applicable to a previously reported grant of 20,000 restricted shares of Class A Common Stock lapsed resulting in the Reporting Person becoming fully vested in such shares. This resulted in no change in the number of shares beneficially owned by the Reporting Person.
- (3) Mr. Biddle is the direct beneficial owner of 174,200 shares of Class A Common Stock (including the 42,500 restricted shares referenced in Footnote (2)). Additionally, he is the indirect beneficial owner of 5,030 shares of Class A Common Stock, of which 4,475 shares are owned beneficially and of record by Catherine U. Biddle, the Reporting Person's wife, and 555 shares are owned by the Catherine U. Biddle IRA for the benefit of Catherine U. Biddle.
