- Pursuant to the merger agreement (the "Merger Agreement") among the issuer, Broadcom Corporation ("Broadcom") and I&N Acquisition Corp., this restricted stock unit (RSU) award was assumed by Broadcom and converted into an RSU award for a number of shares of Broadcom common stock equal to the product (rounded down to the nearest whole share) of (a) the unissued number of issuer shares subject to such award, multiplied by (b) a fraction (the "Option Ratio"), the numerator of which is 50, and the denominator of which is the volume weighted average price for a share of Broadcom common stock for the five trading days immediately prior to (and excluding) February 17, 2012, as reported by Bloomberg, L.P.
- (1) This RSU award provided for vesting in full on May 5, 2012.
 - (2) This RSU award provided for vesting in full on November 5, 2012.
 - (3) This RSU award provided for vesting in full on May 15, 2013.
 - (4) This RSU award provided for vesting in full on November 15, 2013.
