- (1) Each Performance Stock Unit represents a contingent right to receive one share of HTZ common stock. The Performance Stock Units vest in three tranches, contingent upon the recipient's continued employment. The first and second tranches each consist of 25% of the grant and the third tranche will consist of 50% of the grant. The first, second and third tranches vested on March 4, 2011, March 4, 2012 and March 4, 2013, respectively.
- (2) Includes 14,804 shares acquired through the Employee Stock Purchase Plan.
- (3) Shares withheld to pay tax liabilities incident to the vesting of Performance Stock Units.
