- (1) Each Performance Stock Unit represents a contingent right to receive one share of HTZ common stock. The Performance Stock Units vest in three tranches, contingent upon (a) the recipient's continued employment and (b) EBITDA of the issuer during the 2012 and 2013 fiscal years. The first and second tranches each consist of 25% of the grant and the third tranche will consist of 50% of the grant. The first tranche vested on March 6, 2013, and the second and third tranches will vest on March 6, 2013 and March 6, 2014, respectively.
- (2) Includes 10,906 shares acquired through Employee Stock Purchase Plan and 8,237 unvested Restricted Stock Units.
- (3) Shares withheld to pay tax liabilities incident to the vesting of Performance Stock Units.
