The Reporting Persons also own 6,300 shares of Series B Preferred Stock that are convertible into 3,442,623 shares of Common Stock. The beneficial ownership of each Reporting Person is as follows: (i) Fund beneficially owns 2,491,804 shares of Common Stock representing approximately 8.0% of the class and also 5,040 shares of Series B Preferred Stock that are convertible into 2,754,098 shares of Common Stock and (ii) Capital, as the investment adviser and sole general partner of the Fund and investment adviser to an account owned by a separate investment vehicle which holds shares of the Issuer's Common Stock, and Mr. Kolchinsky as the manager of Capital, each beneficially own 3,114,755 shares of Common Stock of the Issuer representing approximately 9.9% of the class and also 6,300 shares of Series B Preferred Stock that are convertible into 3,442,623 shares of Common Stock. The Series B Preferred Stock referred to above may not be converted such that the number of shares of common stock held by the Reporting Persons after such conversion exceeds 9.99% of the outstanding shares of common stock ("Beneficial Ownership Limitation"). The Preferred Shares are eligible to vote with the common stock of the Company on an as-converted basis, but only to the extent that the Preferred Shares are eligible for conversion without exceeding the Beneficial Ownership Limitation.
