On March 3, 2009, Northwest Bancorporation, Inc.'s wholly owned subsidiary, Inland Northwest Bank, (the "Bank") entered into a renegotiated lease with Diamond Plaza, LLC (the "Lease Agreement") for the Bank's principal office and main branch, which is located in the Paulsen Center Building at 421 W. Riverside Avenue in downtown Spokane. The Lease Agreement provides for a 10-year term with additional renewal options on approximately 22,971 square fact.
