On March 24, 2011, we entered into consulting agreements with our Chief Executive Officer, Hugh Aird, Judith Baker, and Steven Cook, regarding their respective management consulting services rendered to the Company from March 31, 2010 to March 31, 2011. In consideration of the services, on March 28, 2011, we approved the issuance of

2,000,000 restricted common shares in our capital stock to each Mr. Aird, Ms. Baker, and Mr. Cook,. The closing price of our common stock at the close of trading on the OTC Bulletin Board on March 28, 2011 was \$0.27.

2,000,000 common shares were issued to one U.S. person (as that term is defined in Regulation S of the Securities Act of 1933) relying on the exemptions from registration provided by Section 4(2) of the Securities Act of 1933 and upon Rule 506 of Regulation D of the Securities Act of 1933, and 4,000,000 common shares were issued to two non-US persons (as that term is defined in Regulation S of the Securities Act of 1933) in offshore transactions relying on Regulation S and/or Section 4(2) of the Securities Act of 1933.
