There was a significant increase in the Registrant's net loss from the three months ended June 30, 2005 to the three months ended June 30, 2006, mainly attributable to decreasing revenues, payment of licensing fees and implementation of Financial Accounting Standard No. 123 (revised) "Share Based Payment". The Registrant anticipates a net loss of approximately \$2.7 for the three months ended June 30, 2006 and \$3.7 million for the six months ended June 30, 2006 compared to a net loss of approximately \$870,000 and \$1.7 million for corresponding periods of 2005.
