On June 2, 2015, pursuant to a plan of disposition adopted in accordance with Rule 10b5-1 of the Securities Exchange Act of 1934 (the "10b5-1 Plan"), Mr. Huck sold 6,000 shares in multiple trades at prices ranging from \$28.18 to \$28.77.
