On April 5, 2016, pursuant to a plan of disposition adopted in accordance with Rule 10b5-1 of the Securities Exchange Act of 1934 (the "10b5-1 Plan"), Mr. Huck sold 4,000 shares in multiple trades at prices ranging from \$27.41 to \$28.02.
