Each Deferred Stock Unit was equivalent in value to one share of NRG Energy, Inc.'s Common Stock, par value \$.01 per share. On June 1, 2016, Mr. Hantke received from NRG Energy, Inc. one such share of Common Stock in exchange for each Deferred Stock Unit he was issued on that same date.
- (2) Reflects a reduction of 355 dividend equivalent rights ("DERs") that vested in connection with Deferred Stock Units granted in prior years, resulting in the Reporting Person holding 499 DERs in the aggregate.
