- (1) Mr. Kline was granted an aggregate of 118,421 restricted stock units, subject to the satisfaction of vesting requirements over a five-year period. Upon vesting, Sunstone Hotel Investors, Inc. will deliver one share of Common Stock for each vested restricted stock unit. Mr. Kline has only the rights of an unsecured creditor in the restricted stock units, and no rights as a stockholder of Sunstone Hotel Investors, L.L.C. until the restricted stock units vest.
- (2) On October 26, 2004, 29,605 restricted stock units vested, and 10,495 shares of Common Stock were withheld to satisfy tax withholding obligations.
