- (6) Phantom stock is reported in units vs. shares in the D&B Common Stock Fund of the issuer's non-employee directors' deferred compensation plan (the "Plan").

Each phantom stock unit entitles the reporting person to a cash payment based on the value on the payout date of the issuer's common stock corresponding to such units. Based on the \$98.05 closing price of the issuer's common stock on the transaction date, each unit corresponds to approximately 2.68 shares.

- (8) The reporting person may transfer these phantom stock units to alternative investment funds in the Plan.
