Upon vesting, Sunstone Hotel Investors, Inc. will deliver one share of Common Stock for each vested restricted stock unit. Mr. Alter has only the rights of an unsecured creditor in the restricted stock units and no rights as a stockholder in Sunstone Hotel Investors, Inc. until the restricted stock unit vests.
