All RSUs vested in full on March 13, 2009. Threshold funding under the 2008 Section 16 Corporate Incentive Compensation Plan was attained.

- (2) Represents quarterly vesting of December 13, 2007 RSU grant. Original grant was 8,000 RSUs, with 20% vested on December 13, 2008, and the remaining 80% vesting in equal quarterly installments over the remaining four years.
- (3) Represents election by individual, as part of the Company's Corporate Incentive Compensation Plan, to receive half of his annual bonus in RSUs, based upon the Company's stock price as of March 13, 2009. All RSUs will fully vest on March 13, 2010.
