 The 35,000 shares were sold through separate trades, with the sale prices ranging from \$14.00 to \$14.14, at a weighted average sale price of \$14.046. - (2) Grant to the Reporting Person of option to buy 35,000 shares of Common Stock under the Issuer's 1997 Stock Plan. The option is exercisable in whole or in part from its date of grant, subject to a repurchase option in favor of the Issuer, and vests at the rate of 1/4th of the shares on August 15, 2006 and as to 1/4th of the shares on each one year anniversary thereafter.
