The Restricted Stock Units vest 25% on October 10, 2008, 25% on October 10, 2009, 25% on October 10, 2010 and 25% on October 10, 2011.

(2) Virgin Group and the reporting persons, the Virgin Group purchased from the reporting person the shares deliverable upon such vesting for \$4.72 per share.
