All shares of common stock that are beneficially owned by Reporting Person are Restricted Shares, which vest in two equal installments on the last day of each of the two fiscal quarters of service following their grant date (with the first vesting on March 31, 2010), with vesting subject to continued service during each fiscal quarter.
